

Client Overview: A Fortune 500 multinational corporation with operations in over 60 countries sought to digitize and streamline its financial audit processes through a centralized, cloud-based module that integrates with its existing ERP and compliance systems. The goal was to reduce manual audits, enhance regulatory compliance, and provide real-time visibility into financial controls.

Duration: 12 Months (Mar 2024 - Mar 2025)

Project Scope

- Develop a secure, scalable, and globally accessible financial audit module that:
- Supports multi-currency and multi-jurisdiction compliance
- Integrates with SAP and Oracle ERP systems
- Provides AI-based anomaly detection
- Enables real-time dashboards and role-based access control

Technology Stack

- Frontend: React.js with TypeScript for dynamic UI
- Backend: Node.js with Express
- Database: PostgreSQL and MongoDB (hybrid for structured + unstructured data)
- AI/ML: Python (TensorFlow, Scikit-learn) for anomaly detection algorithms
- DevOps: Docker, Kubernetes, Jenkins, GitHub Actions
- Cloud: AWS (EC2, S3, RDS, IAM, Lambda)
- Security: OAuth2, SAML, and end-to-end encryption using TLS 1.3
